## ORDER

In the reference read above, Ministry of Fisheries, Animal Husbandry & Dairying, Department of Fisheries, Government of India has issued order to impose a uniform ban on fishing by all fishing vessels in the Indian Exclusive Economic (EEZ) beyond territorial waters on the West Coast (including Gujarat, Daman & Diu, Karnataka, Goa, Maharashtra, Kerala, Tamil Nadu and Lakshadweep Islands) for period from 1<sup>st</sup> June to 31<sup>st</sup> July 2024. Similar, fishing ban period is also applicable within territorial waters for effective conservation, management of fisheries resources and for safety of fisher folks. During the fishing ban period, the utilization of VAT-Exempt Diesel will also be prohibited within the Union Territory of Dadra & Nagar Haveli and Daman & Diu.

Fishermen/Boat owners will restrain their fishing vessels for fishing purpose during bad weather condition and obey weather warning issued by Indian Meteorological Department.

The traditional fishing crafts are exempted from this uniform fishing ban imposed in the territorial waters and restricted to operate up to five nautical miles.
